

Iran to reopen Hormuz, regain access to oil markets under proposed MoU

Deal opens a 60-day period for nuclear talks while offering Tehran benefits with little in return

DUBAI Iran will immediately take steps to reopen the Strait of Hormuz once a tentative deal with the US to end the war is signed and will be allowed to sell its oil without restrictions, according to leaked copies of an interim agreement that officials say broadly matches the document.

The US and Israel went to war on February 28 in part to prevent Iran from ever getting a nuclear weapon, although US President Donald Trump's goals in the conflict have repeatedly shifted. The interim deal stops the war before that aim is secured. Instead, it opens a two-month period for nuclear negotiations and appears to offer Iran several benefits up front while extracting little in return.

The accord likely will draw intense opposition in Washington, and it appears to be a major setback for Israeli Prime Minister Benjamin Netanyahu, who has come under criticism at home from the media, his opponents and even some allies as details emerge.
